10.7 Field Dues Reimbursement

The portion of their field dues, which is retained by the Lodge under the Constitution, shall be reimbursed to the field construction steward and MOST safety person for each month during which:

- 10.7.1 Their official duties have been performed in a proper, timely manner, and all records and reports required of them are up-to-date.
- 10.7.2 They are assigned to a project as steward or as a MOST safety person, consisting of ten (10) or more persons, including themselves.
- 10.7.3 They attend the monthly meeting or are properly excused in accordance with 5.2 and 5.3 thereof.
- 10.7.4 The Lodge's total liquid assets do not drop below \$1,250,000.00.
